Presenters

Presenters are invited to come to the room 5 minutes prior the start of the session, so that presentations can be copied, if not sent in advance, onto the computer before the session starts.

Each presenter will be discussing a paper.

Chairs

Chairs are invited to come in the room 5 minutes prior to the start of the session. They introduce the session and the presenters. They make sure that the time available is equally divided over presenters and guide the general discussion.

Each parallel session in the programme of the ICDE 2022 will be chaired by the last presenter of the session.

A few remarks on this important role:

- 1. The fundamental role is to help the presenters and the discussants to respect the time that is assigned to them, and to manage the interventions of the other participants. Each presenter will have 20 minutes, followed by 5 minutes for the discussant and another 5 minutes for the interventions of all the participants, and the replies of the presenter. It is important not to exceed the slot of 30 minutes for each paper. The chairperson will be provided with papers with 10, 5, 2 and 0 minutes left notices. The chairpersons should not hesitate to remind to other participants that they need to be coincise when asking questions, and to suggest that additional exchanges can take place on a bilateral basis after the session.
- 2. Chairpersons should not let discussants use most of their limited time summarizing the main findings of the paper that has just been presented. Thus, they should not hesitate to push them to move immediately to the more substantive part of their discussion.
- 3. Some parallel sessions might have three papers while other parallel sessions scheduled at the same time have four. It is important to respect the 30-minute slot for each paper also in sessions with just three papers. This can allow participants that want to attend presentations of papers in different parallel sessions.
- 4. We will inform the chairpersons in case of last-minute changes in the programme. Notably, if a discussant is unable to participate, the chairperson should provide some personal feedbacks to the presenter before opening the floor to the questions from the other participants.


Discussants

Discussants are expected to briefly comment by focusing on specific questions in order to leave sufficient time for the general discussion with participants (avoid summarizing the paper or its main findings). The name of discussants will be provided on the program.
